If the office happens to be closed on the date of opening of the bids as specified, the bids will be opened on the next working day at the same time. Any bid received by DFS, Assam after the deadline for submission of bids will be rejected and returned unopened to the bidder. Bids will be opened in the presence of Bidders or their representatives who choose to attend in Directorate of Forensic Science, Assam.

- 7. The Bidder is expected to examine all instructions, forms, terms and specifications in the bidding documents. Failure to furnish all information required by the RFQ documents or submission of a bid not substantially responsive to the bidding documents in every respect will be at the bidder's risk and may result in the rejection of its bid.
 - 8. Supply order quantity may increase or decrease depending on the needs of DFS, Assam. Supply order will be placed on need basis only.
 - Quotations will be evaluated and the winner will be declared on the lowest over all evaluated price.
